- Maintain Ontario Ministry of Children, Community and Social Services (MCCSS) licensing standards and regulations, in accordance with the Ombudsman's Quality Standards, Framework, Child, Youth and Family Services Act, 2017 (CYFSA), the Youth Criminal Justice Act (YCJA) and the Provincial Offences Act (POA).
- Ensures consistent provision and proper care and supervision of young persons in care
- Advocate for young persons in care and ensure their rights and responsibilities are protected and understood
- Participate in Case Management and Reintegration planning meetings
- Innovate, optimize partnerships and foster Community collaborations
- Establish and maintain collective bargaining relations
- Carry out on-call requirements as scheduled
- Coordinate and carry out facility inspections as required
- Maintain administrative and documentation requirements
- Maintain financial accountability
